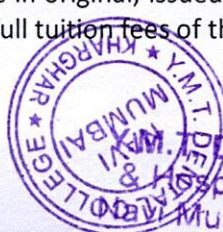

Important Instructions :

Candidates who are admitted under Open quota only through CAP round and their parents annual income is below Rs. 8,00,000/- are eligible for the Govt. Rajashree Chatrapati Shau Maharaj Shikshan Shulka Scholarship. Candidates admitted under Institutional round are not eligible for the same and should pay the full tuition fees.

As per the instructions from CET CELL ,candidate who have eligible for the Economical Backward Class Rajashree Chatrapati Shau Maharaj Shikshan Shulka Scholarship are hereby instructed to submit their parents annual Income certificate in original, issued by Tehasildar Office at the time of admission, failing which they have to pay the full tuition fees of the Open Category.
